All plants in this garden are native plants and were sourced in Vermont (our thanks for recommendations from our local Conservation Commissions in Montgomery, Richford, Enosburg, and Bakersfield). ### **Stream Wise Visits**

For a second year, the MRBA participated in the Stream Wise program hosted by the Lake Champlain Basin Program. MRBA staff visited six landowners in Orleans County and surveyed streams which lead into the Missisquoi River. The goal of the Stream Wise program is to enable direct contact with landowners to discuss wavs they might improve their relationship with their stream, potential projects to improve stream health, and to learn about how our waterways are connected. ### 2024 Lake Lessons

For the fifth year, the MRBA participated in and helped host Lake Lessons. This collaborative experiential education program provided 4th graders from three local schools a half-day learning 'field trip'. Seven local agencies and organizations set up stations for students to learn about our impacts on Lake Champlain. Topics covered included water quality, history, stormwater runoff, and more. These lessons allow students to build watershed knowledge. and introduce how we can create positive change through the ways we interact with the world around us. Lake Lessons took place during Ruby's first week of service, and she led the program so wonderfully thanks for your hard work Ruby! We are already planning for next year!







### **River Clean-Up Round-Up**

This summer, the MRBA hosted two river clean-ups along **4** river miles of the Missisquoi in Swanton and the Trout River in East Berkshire. We got **22** people out on our river and collected tires, rusty metal, house siding, broken glass, a baseball hat, and lots more all adding up to approximately **300 lbs** of trash! ### **2024 Tree Plantings**

In 2024, MRBA staff and volunteers planted 750 trees during the spring. We were joined by a class from North Country Union High School (NCUHS) and a group of students from the Bronx traveling with CatRock Ventures. We love being able to teach today's youth about the importance of riparian restoration! Tree species planted include sugar maple, silver maple, red maple, white spruce, white pine, balsam fir, box elder, and basswood which will all help withstand future weather events. These trees, and those from previous plantings, will help protect and preserve the banks of the Missisquoi River and watershed streams for years to come. We will be planting again in 2025 and are always welcoming volunteers!

## **Big Changes Flowing Downstream**



Since 1996, the MRBA has been heavily invested in protecting and restoring the waters that flow through the Missisquoi watershed. As we flow towards 2025, the MRBA is setting up starting blocks for future success. This year the MRBA established our native tree nursery in the headwaters of the Missisquoi, planting 700 seedlings in a foundational bed along the Jay Branch. Our nursery location, in the town of Jay, is ideal habitat to propagate native species, and is an important community asset - this property also hosts the Catamount Trail and a much enjoyed VAST trail. MRBA has collaborated with community members over the past year, and are ecstatic to announce that we are working with the Town of Jay and the Lake Champlain Basin Program to purchase and conserve the important parcels that make up this floodplain. We are paddling into unexplored waters with land ownership, but we are prepared and ready to learn. Pursuing the purchase of this land has enabled the vision of a community that will pair recreation trails, educational and stewardship programs along the significant and important wetland complex at Jay Branch. The property's conservation will protect the wetlands on the parcel and improve it's functions of flood protection, water purification, wildlife habitat, and provide a space for the community to enjoy.

### **Restoring Flows to Mud Creek**

For a number of years, the MRBA has working with involved landowners to explore the potential removal of the Sleeper Pond Dam in Newport Center. This dam has not functioned for a long time and is, in fact, at risk of failing. MRBA has secured funding and plans to pursue removal in summer of 2025. Restoration of this natural stream channel will reduce risk and improve the surrounding habitat.
