MRBA Meeting Minutes Thursday May 5th, 2023: MRBA Office

1) Meeting began at 6:36pm with greetings and introductions

2) Review of April meeting minutes: PS motioned to accept, CS seconded. All in favor; minutes accepted as written.

- 3) Administrative business
 - MRBA received the Lake Champlain Basin Program Organizational Support grant for equipment to have a screen to have Zoom meetings projected.
 - Banking: John collected materials from two different banks: Peoples Trust and Community National to decide if we should change banks. Craig suggested Community National Bank because they are on both sides of the Mountain. Also, because they are community banks instead of a large corporate bank. Paul commented that TD Bank did give us money through the Affinity program, although we did have to solicit members to join the bank. WS motioned to leave TD; CC seconded; motion passed. CC motioned to open and account with CNB; JL seconded; motion passed.
 - Check writing: Paul, Kate, Wendy, and Cynthia volunteered to sign checks.
 - Warrant system: Lindsey explained her new system using a warrant. All board members looked it over. Moving forward: Lindsey should distribute the Warrant early, so that Board members can look it over and ask any questions. Then the agenda item can just consist of approving it.
 - Board Recruitment: Discussion about possible new people who might be available to join the board. Wendy mentioned someone in Fairfield. Lindsey mentioned that it would be good for us to find someone from Orleans County. The problem is for them to travel to the office for meetings and that there are fewer people to choose from in Orleans County. Craig reported that he wrote up a "Call to action" to recruit board members. Craig has a new job at Jay Peak as Director of Ski and Ride School and Community Relations. Craig pointed out that since MRBA is a community entity so it would be appropriate to bring MRBA into the Jay Peak community.

10) Other business: Paul, Craig, and Lindsey went to the Brownway Trail and collected all of the leftover plastic tree protectors. Paul mentioned that the filter fabric isn't removed from the trees at Brownway and they will girdle the trees if they're not removed. Discussion about how to go about removing it. Possibility of having a Community Service Day with Jay employees. Ellen suggested putting 5 days on the calendar to visit previous sites.

NRCD tree planting brochure. Paul shared a packet that will be given out at the tree sale this weekend. JL would like to connect with Walter Elander regarding concerns about expanding snowmaking.
